Terms & Conditions

Conditions

Lifestyle Barbeques are manufactured from high quality 304 grade stainless steel material to ensure years of low maintenance service. When not in use, your Barbeque should be stored under cover. Unnecessary exposure to prevailing weather conditions should be minimised. The Barbeque should be wiped over with a suitable stainless steel cleaning solution once a month to remove any build up of grease, oil, salt and grime that might otherwise cause the surfaces to tarnish over time. It is recommended that a heavy duty polyester Barbeque cover protect the barbeque when not in use.

Remember to change the fat absorbent material in your BBQ drip tray frequently. If you do not, fat, oil and food residues will build up and may catch fire. Your warranty does not cover damage from fat fires.

The appliance must be operated and maintained in accordance with the Lifestyle Barbeque instructions, available on the BBQ owners page of www.lifestylebbqs.com.

The Lifestyle Barbeque warranty applies only to the original purchaser of the appliance. This warranty covers only the repair and/or replacement of defective parts during the warranty period as detailed. It does not include consequential losses or damages arising from use of the appliance. Warranty repairs will only be carried out at the Lifestyle Barbeque factory. Alternatively if a replacement part is necessary to correct a defect it can be provided by courier or by mail. Fitting of the part is to be at the expense of the owner. The owner accepts responsibility for instructing a suitably qualified person to fit the replacement part.

It is the owner's responsibility to deliver their barbeque to and collect from the Lifestyle Barbeque factory at their own expense should a warranty claim be made and accepted by ABM.

Proof of purchase and date of purchase (eg copy of supplier invoice) will be required at the time a warranty claim is made. Images of any defects and a written statement of claim will also be required.

The warranty provides **no cover** for:-

Repairs or modifications done by unauthorised persons.
Malfunction due to lack of care in handling or mechanical damage, abuse or neglect.
Incorrect installation of the appliance. Improper operation of the barbeque.
Cleaning and wear and tear as a result of normal use.
Commercial use of barbeque for business purposes (ie other than for domestic use).
Installation and use of non standard or non genuine components.
Colour change, surface marking, tarnishing or corrosion.
